The solicitors on the panel reserve the right in all cases to accept or refuse instructions and the Society recommends that solicitors on the panel should not accept instructions to bring proceedings against a local colleague. For your assistance the attached list is divided into counties and identifies the different areas of law in which instructions will be accepted.
