Privacy Statement for Justice Media Awards

We are the Law Society of Ireland of Blackhall Place, Dublin 7, Ireland (the “**Law Society**”, “**we**”, “**us**”, “**our**”). We are the educational, representative and regulatory body of the solicitors' profession in Ireland.

We take our responsibilities under applicable data protection law, including the General Data Protection Regulation and implementing legislation such as the Data Protection Act 2018 very seriously. The purpose of this notice is to inform you of the personal data relating to you that we may collect and use (including disclosures to third parties) we may make of such data.

Personal Data that we collect and Process

We will collect and process personal data relating to you. This personal data may include:

- your name and contact details, including your home address, your practising address, phone numbers, email address and post code;
- your credit/debit card or bank account details; (should you win a monetary award)
- any other personal data which you provide to us directly.

Purposes of Processing and Legal Basis

We, and third party service providers acting on our behalf, may use personal data relating to you for the purposes and based on the legal basis set out below:

Sources of Data

The data we process is collected from the Society’s internal databases, such as the roll of the solicitors as well as the data you provide to us yourself.

Recipients of Data

We may disclose your personal data to other organisations in connection with the above

purposes, including:

- To third parties who we engage to provide services or benefits to us or to you, such as professional advisers, auditors, insurers and outsourced service providers;
- In certain limited circumstances, to commercial entities.
- Authorities, in cases where we are under legal obligation to do so
- Media present at the awards and associated events

Retention

We will not hold your data for longer than is necessary. We may retain your personal data for the duration of your relationship with the Law Society and for such period of time thereafter as is necessary to comply with our legal and regulatory obligations.

Transfers Abroad

In connection with the above we might transfer your personal data outside the European Economic Area, including to a jurisdiction which is not recognised by the European Commission as providing for an equivalent level of protection for personal data as is provided for in the European Union. If and to the extent that we do so, we will ensure that appropriate measures are in place to comply with our obligations under applicable law governing such transfers. These may include entering into a contract governing the transfer that contains the 'standard contractual clauses' approved for this purpose by the European Commission. Your rights

You have the following rights, in certain circumstances and subject to certain restrictions, in relation to your personal data:

- **Right to access the data** – You have the right to request a copy of the personal data that we hold about you, together with other information about our processing of that personal data.
- **Right to rectification** – You have the right to request that any inaccurate data that is held about you is corrected, or if we have incomplete information you may request that we update the information such that it is complete.
- **Right to erasure** – You have the right to request us to delete personal data that we hold about you. This is sometimes referred to as the right to be forgotten.
- **Right to restriction of processing or to object to processing** – You have the right to request that we no longer process your personal data for particular purposes, or to object to our processing of your personal data for particular purposes.
- **Right to data portability** – Where our processing of your personal data is based on (i) you having provided your consent, or (ii) being necessary for the performance of a contract with you, you have the right to request us to provide you, or a third party, with a copy of your personal data in a structured, commonly used machine readable

format.

- **Right to withdraw your consent** – Where our processing of your personal data is based on you having provided your consent, you have the right to withdraw such consent.
