### **John Furlong, Knowledge Management consultant, Law Society Technology Committee member, Dublin**

John has over 25 years of experience in Irish legal research and in the development of legal resource and knowledge solutions. He is a solicitor by profession and has worked in senior positions in two of Ireland's leading law firms. John has acted as visiting lecturer in legal research and European legal research at the Law School of the Law Society of Ireland for many years. He has written regularly on the topic of Irish legal resources and has presented on this topic at international conferences in Canada, the United States and the UK. He is a long time member and former chair of the Technology Committee of the Law Society of Ireland and has served as an Irish delegate to the CCBE on legal technology matters. John was the first Irish person to chair the British & Irish Association of Law Librarians and was active on the Association's Conference Committee for many years. Specialties are Legal Research, Irish Legal System, Knowledge Management, and Legal Education.

### **Dr Rachael Hession, Solicitor, Law Society of Ireland**

Dr Hession is a course manager on the Law Society's Professional Practice Courses and is a programme manager with Law Society Professional Training. She lectures and tutors on the PPC. She is co-editor and co-author of the Law Society Complex Conveyancing Manual and is co-author of the Law Society Capital Taxation for Solicitors Manual and Conveyancing Manual.
