## Aine Hynes SC, St John Solicitors

Áine is a partner in public and administrative law in St.John Solicitors. Áine has been a member of the Council of the Law Society and many of its committees (which include Litigation, Regulation of Practice and Education) since 2007 and served as President of the Dublin Solicitors Bar Association (2016 - 2017). She was appointed by Minister Lynch to the Expert Steering Group on the Review of the Mental Health Act 2001 (2012-2015) and was a member of the Regional Advisory Board of the National Advocacy Service (2013-2017). In May 2022, she was appointed by the Minister for Justice to the Civil Legal Aid Review Group. Áine currently chairs the Law Society Mental Health Law and Capacity Taskforce and has made extensive submissions to the department of Children, Equality, Disability, Integration and Youth on appropriate amendments to the Assisted Decision-Making (Capacity) Act 2015. Her novel submissions on transitional arrangements were accepted by the department, thus ensuring a more orderly transition from wardship to the new legal capacity framework. Áine was one of the first solicitors appointed Senior Counsel in October 2020, following a historic move permitting solicitors to be granted patents of precedence.

Áine Flynn is a graduate of Trinity College Dublin. She is a solicitor and former partner in Dublin firm KOD Lyons. While in private practice she specialised in public interest law, including mental health and capacity. She has been a member of the Human Rights Committee of the Law Society of Ireland since 2012. Prior to her present appointment, she was a member of the Law Society's Mental Health and Capacity Task Force. In October 2017, Áine commenced in post as the first Director of the Decision Support Service under the Assisted Decision-Making (Capacity) Act 2015.

Jim Finn is the head of the Legislation and Rules Unit of the Courts Service and he has over 40 years' experience in the Courts Service. He has worked in a number of front-line court offices as well as in administrative and support areas in the Service. Jim is a qualified barrister and was Registrar of Wards of Court from 2010 until 2019 before his assignment to the Legislation and Rules Unit.
