Annalise's first embarked on her sailing journey at Blessington Sailing Club. After a successful youth career, she had the honour of representing Ireland in the Olympic Games three times, with a memorable silver medal win in Rio 2016 in the women's single-handed dinghy class. Annalise ventured beyond the Olympics to participate in the 2017/18 Volvo Ocean Race, a demanding 9-month circumnavigation of the globe as part of the "Turn the Tide on Plastic" team, sailing alongside some of the world's best sailors. Post-Tokyo 2021, Annalise decided to pursue a full-time MBA at Trinity College Dublin while still staying involved in sailing and helping the next generation of Olympic athletes through coaching and representing them on the OFI Athletes Commission.

Sara Phelan SC, Chair of the Bar Council

Sara Phelan SC has been elected as forthcoming Chair of the Council of the Bar of Ireland. The third female ever to lead the organisation, she takes up the position in September 2022.

A Kilkenny native, Sara was called to the Bar in 1996, having previously qualified and practised as a pharmacist for a number of years, qualifying from Trinity College Dublin (1988). Sara was appointed Senior Counsel and called to the Inner Bar in 2013. A qualified mediator and arbitrator, Sara was admitted to the Bar of England & Wales in 2019 and is a member of Middle Temple.
