She is a dedicated activist and advocate inspired by the African principle of Ubuntu (I am because we are) which speaks to community, unity, respect, and dignity. Joy-Tendai is fuelled by being community-focused and authentically using her voice to elevate everyone that she connects with. Joy-Tendai is an international public speaker, writer, columnist, trainer, lecturer and Founder. She regularly contributes to topics of race, justice and equity as well as being called upon for her expertise in justice, diversity, equity, and inclusion advocacy. She is the Founder Roots in Africa-Ireland, a not-for-profit that empowers the African-Irish community through various social and educational programs. Born in Zimbabwe, Joy-Tendai is the first female recipient of the Denham Fellowship, Committee Member of the Climate Bar Association, Committee Member of the Bar of Ireland Equality & Resilience Committee and former Board Member of AONTAS(Adult Learning Charity).

#### Kate McKenna, In-house legal counsel, Frontline Ventures

Kate McKenna is in-house legal counsel for Frontline Ventures, a venture capital firm based in Dublin with offices in London and San Francisco. She has been a qualified Irish lawyer since 2011. She trained and worked in a large Dublin law firm before moving in-house in 2013 as commercial IT/IP counsel for an international gaming company before making the move to venture capital in 2020. She is a member of the Council of the Law Society of Ireland since November 2022 and sits on a number of standing and non-standing committees including the technology, in-house and public sector and regulation of practice committees. She has published writings on topics such as assistive technology in the legal sector, Al and bias and most recently contributed to a round table discussion last October which looked at the state of lawtech in the Irish courts and the wider legal profession.
