Cathal Ryan, Deputy Commissioner, Data Protection Commission Ireland

Cathal Ryan is a Deputy Commissioner with the Data Protection Commission Ireland having re-joined the organisation at the start of 2023. Prior to this, Cathal held a number of senior management regulatory roles including Deputy Director of Product Safety with the Irish Competition and Consumer Protection Commission and as an Assistant Commissioner with the Data Protection Commission.

Cathal is a qualified lawyer who worked for the Legal Aid board and the CSSO successfully transitioning from litigation into commercial law. This latter role steered his interest towards digital regulation. Cathal now leads the Supervision function of the DPC in respect of various sectors such as Multinational Technology and Finance. He is also responsible for Certification and International Transfers. As a member of the European Data Protection Board, Cathal regularly contributes to guidance and decisions through his involvement in a number of subgroups and at plenaries. He delivered Code of Conduct guidelines as the lead rapporteur and continues to be heavily involved in many keys areas of work of the Board.
