Judge Schlegel is the recipient of the National Center for State Courts' 26th Annual William H. Rehnquist Award for Judicial Excellence, one of the highest judicial honors in the country, and was featured on the cover of the American Bar Association Journal after being named a 2021 Legal Rebel. As a District Court Judge, Judge Schlegel handles a variety of cases, including criminal, civil and domestic. Judge Schlegel also serves as a volunteer judge for two specialty courts he started in Jefferson Parish; Reentry Court and Swift & Certain Probation. Judge Schlegel works tirelessly to improve the justice system. He has written and spoken nationally about these critical improvements to the justice system on many occasions.
