Cindy Carroll, Deputy Chairperson, International Protection Appeals Tribunal

A graduate of law from University College Cork, Cindy was called to the Bar of Ireland in 1995. Following a devilling year in Dublin, she practised as a barrister in Cork, and lectured in Cork Institute of Technology and University College Cork. In 2001, she was then appointed as Advisory Counsel at the Office of the Attorney General and worked there advising primarily on asylum and immigration law. She returned to the Bar in Dublin in early 2004 and was briefed as counsel on the State Asylum and Immigration Panel from 2004 until March 2018. During this time, she lectured in the Dublin Institute of Technology, and both lectured and tutored in the Law Society of Ireland.

In March 2018, Cindy was appointed as Deputy Chairperson of the International Protection Appeals Tribunal, where she is a member of the senior management team, Head of Training and a decision maker in asylum-related appeals. In May 2019, she made the first preliminary reference from the Tribunal to the Court of Justice of the European Union. Cindy has successfully an MA in Leadership and Strategy and is currently studying for a Doctorate in Governance. She has been a member of the pool of Judicial Trainers with the EUAA (formerly EASO) since 2021.

Dr Aoife McMahon BL

Aoife has lectured in EU law, Immigration law and refugee law in TCD, UCD, Maynooth University, Griffith College, the Kings Inns and the Law Society of Ireland and has had a number of articles published in this area. Her book, *The Role of the State in Migration Control* was published by Brill Nijhoff in December 2016 as part of its series on Immigration and Asylum Law and Policy in Europe.

She has worked in the CJEU, Unesco and Médecins du Monde. In her 13 years of experience as a practising barrister, she has acted in cases before the Irish superior courts, the CJEU and the European Court of Human Rights.

Julia Hull, Managing Solicitor, Legal Aid Board, Law Centre Cork

Julia Hull has worked for the Legal Aid Board since 2001, working as a solicitor for Refugee Legal Service in Cork until 2010 and then with the Law Centre (Cork North) where she has continued to represent clients who have applied for International Protection. With over 20 years' experience of representing clients in this area Julia is now one of the Managing Solicitors of the Law Centre (Cork North) with particular responsibility for managing the International Protection service in that office.

Hilkka Becker, Chairperson of the International Protection Appeals Tribunal (Ireland)
Hilkka has been the Chairperson of the International Protection Appeals Tribunal since April

2017. She was previously a Deputy Chairperson of the Tribunal and served as a part-time Member of the Refugee Appeals Tribunal from 2013 to 2016. Over the course of her career to date, she was Senior Solicitor at the Immigrant Council of Ireland – Independent Law Centre, for over 10 years, Regional Legal Advisor and consultant with the International Organization for Migration (IOM), solicitor in private practice and Legal Officer with the Irish Refugee

Council.

Hilkka is an experienced public speaker, lectures at the Law Society of Ireland and acts regularly as a judicial trainer for the EU Asylum Agency (EUAA). She is an active member of the International Association of Refugee and Migration Judges (IARMJ), a Fellow of McLaughlin College at York University, Toronto and a member of the Justice and Home Affairs Group and of the Germany Group of the Institute of International and European Affairs (IIEA) and of the European and International Law Committee of the Law Society of Ireland.

Joanne Williams BL

Joanne was called to the Bar in 2007 and has been practising as a barrister since 2010, specialising in cases with a human rights dimension. From 2008 to 2010, before she joined the Law Library, she was a judicial fellow assigned to the judges in charge of the High Court Asylum, Immigration and Citizenship List, then a division of the Judicial Review List. From 2012 until 2017 she was part of an external panel established by the Office of the Refugee Applications Commissioner to help address a backlog of subsidiary protection applications, and she has been a part-time member of the International Protection Appeals Tribunal since 2018. She has recently been appointed to a pool of 'judicial experts' with the European Union Asylum Agency.
