#### LAW SOCIETY SKILLNET BACKGROUND

The Law Society Skillnet was established in 2007 to address primarily the specialised legal, management and professional development training needs which were not available to member firms to assist them in maintaining competitiveness and sustainability. The secondary aim of the network was to address the training needs of firms in rural marginalised regions of Ireland where relevant specialised training was unavailable due to the specialisation which was required and the costs involved in delivering this training.

The network is funded by member companies and the Training Networks Programme which is an initiative of Skillnets who are funded from the National Training Fund through the Department of Education and Skills. The network is promoted by the Law Society of Ireland.

Over the past few years, the Network has received a number of awards from the Irish Institute of Training and Development (IITD) in the 'Most Innovative Use of Technology' in Teaching and Learning' category, 'Best Work Placement – Graduate and Non- Graduate' Category and in the 'Network and Groups' Category.

#### **Collaborative Networking Events**

The network has delivered five collaborative networking events. The collaborative partners have included the Irish Women Lawyers Association, the Sole Practitioners Network, the Dublin Solicitors Bar Association and the Dublin Institute of Technology. The objective of these events was to enable our member firms to establish new business contacts or indeed reignite old contacts for collegiality, support, knowledge dissemination and business and education advancement. Networking will continue to be a key focus for 2017 as is proposed in the networks application.
