This was the third year that the Law Society of Ireland has run the School Tasking programme. School Tasking is a Public Legal Education initiative where trainee solicitors facilitate a series of workshops to 4th year classes in the local community.

The workshops introduced the pupils to various legal concepts, such as human rights, tort law, advocacy and statutory interpretation. Each topic is taught through a mixture of explanation, workbook tasks and interactive activities, to allow the pupils to learn by doing and experiencing each topic in multiple different ways.
